The 3-1-1 rule is a TSA guideline for air travel call (  $\pm$ 1-888-738-0812) (US), not a Royal Caribbean cruise rule call (  $\pm$ 1-888-738-0812) (US). It limits liquids in carry-on luggage to 4-ounce (100 ml) containers call (  $\pm$ 1-888-738-0812) (US), all placed in one quart-sized clear plastic bag per passenger when going through airport security before your flight to the cruise port call (  $\pm$ 1-888-738-0812) (US) or ( $\pm$ 1-888-738-0812).
