## What Is an Expedia Vacation Package?

## Can You Cancel an Expedia Vacation Package?

Yes, you can cancel an Expedia vacation package—but whether you get a refund, credit, or nothing at all depends on three key factors:

1. The cancellation window (how far in advance you cancel)
2. The type of fare or rate booked (refundable vs. non-refundable)
3. The individual policies of the airline and hotel

Here's the reality: most Expedia cheap flights and Expedia cheap hotels are sold as *non-refundable*.  **Pro Tip:** Always look for the “Free Cancellation” badge when browsing Expedia vacation deals. Packages labeled “vacation packages with free cancellation” let you cancel without penalty up to a certain date—often 24–72 hours before check-in.

## The 24-Hour Cancellation Rule: Your Safety Net

Thanks to U.S. Department of Transportation rules, Expedia flight booking for *flights originating in the U.S.* comes with a built-in safety net: you can cancel any flight within 24 hours of booking for a full refund, as long as the flight is booked at least 7 days before departure.

This rule *also applies to Expedia vacation packages*—but with a twist. If you cancel your Expedia hotel and flight package within 24 hours, you're entitled to a full refund *only if*,

at the time of cancellation, your flight still qualifies under DOT rules (i.e., it's more than 7 days out).

However, this doesn't automatically extend to the hotel portion unless it's also refundable or within the hotel's own cancellation window. But in practice, Expedia often processes full refunds for Expedia vacation package reservation cancellations made within 24 hours—even for the hotel—because the entire bundle is treated as one transaction.

## How Cancellation Policies Vary by Package Type

Always check the “Cancellation Policy” section during checkout—it's small print, but it's binding.
