Can You Cancel an Expedia Hotel for Free?

Canceling Through "My Trips"

Conversely, users ask: **Can Expedia cancel my hotel** or **can expedia cancel my flight** without my permission? Yes, this can happen in specific scenarios:

- 1. **Price Glitches:** If a hotel was listed at an erroneous price (e.g., \$5 instead of \$500), Expedia reserves the right to cancel the booking.
- 2. **Fraud Prevention:** If the payment method is flagged.
- 3. **Overbooking:** If the hotel or airline overbooks, Expedia may be forced to cancel or relocate you.

How to Cancel an Expedia Trip or Vacation Package
